Task Context:

This term in class you have been learning about the importance of agriculture in Australia, and the need for safety to be a focus within the industry due to farming being accountable for 1 in every 5 worker deaths in NSW. You have learnt how eliminating farming to prevent injuries or deaths is simply not possible, therefore, development of safe work practices or best practice methods is important to protect the health and safety of workers in Australia's agriculture industry.

In this assessment you will have the opportunity to demonstrate your knowledge of agriculture's dangers by recognising the *combination of hazards* present in many farming workplaces. Hazards can include machinery, chemicals, noise, dust, exposure to the elements, working with animals and plants, working alone or in remote locations. You will show your understanding of work health and safety requirements appropriate to common farming tasks. You will communicate your understanding of safe work practices and hazard management by creating a safety video or safety poster campaign.

Course Outcomes:

Task Description:

You will work with a partner to complete PART A.

PART A: (15 Marks)

You and your partner will *identify* one common hazard attributed to injuries or fatalities occurring on Australian farms.

You and your partner will create a safety awareness campaign that *explains* the best practice to manage the risk involved with your chosen hazard. You can create <u>either</u> a safety video campaign OR a safety poster campaign to clearly communicate <u>one</u> farm safety message by demonstrating the best way to manage the farm hazard.

The video needs to meet the following:

- Length: no less than 1 and no more than 3 minutes long
- Topic: showcase 1 farm safety message by focusing on best practice
- Audience: target 15-year-olds to adult behaviours
 All videos must be uploaded or emailed to the teacher by the due date

The poster campaign needs to meet the following:

- Number: no less than 1 A4 page and no more than 3 A4 pages
- Topic: showcase 1 farm safety message by focusing on best practice
- Audience: target 15-year-olds to adult behaviours
- Technology: can be paper, cardboard, or digital
 All posters must be handed into the teacher by the due date (can be emailed)

PART B: (5 Marks)

You will complete this section individually.

You will write a rationale for the campaign that justifies the significance of the safety message being communicated in the campaign and the appropriateness of delivery. Hint: why did you choose that safety message and why did you choose to communicate the safety message in this way?
